

Committee Teams: Week of 1/27- 2/1

Hello VA NOW General Assembly Advocates! Please use this document as a tool to figure out where legislation you care about is. Legislation will either be:

- In a committee, waiting for a vote (each committee has a link to its docket, which is where you can find out if your legislation will be voted on that week or day). Typically, dockets are only posted a day or two in advance, so be sure to check your committee docket more than once!
- On the floor, waiting for a full body vote
- Assigned to the opposite chamber, waiting for assignment to a committee post crossover

Remember, we are only asking for you to take action if you see that your bill is on the docket in its committee! If it is on the floor of either the House or the Senate, don't worry about it for now! It won't be assigned to a committee again until after Crossover (which is when bills from the House get assigned and heard in the Senate and vice versa). Crossover is on: Feb 11th!

When you see a bill (s) on the docket, send out an email to committee members:

- List of standing committees: <http://lis.virginia.gov/141/com/COM.HTM> (remember, you can find legislator emails for each committee by clicking on their names, highlighted in blue!)
- State: who you are and what group you are a part of (VA NOW),
- if you support or oppose the bill (s) up for vote,
- why they should support or oppose the bill (s) –use your fact sheets from the 1st GA advocacy email, or simply google the topic for statistics or facts, &
- if you like, ask for a follow up response
